Insurance Rating Changes Force Fire Apparatus Upgrade

Recent changes to the national fire department ratings system is forcing the Colington Volunteer Fire Department to purchase a ladder truck to meet the new requirements. The change mandates that an aerial ladder truck respond to all structure fires due to a change in the minimum building height threshold from 35 feet to 32 feet. The fire department had hoped to start the process of ordering the new ladder truck right away, but recent rejection of a proposed fire tax increase by Dare County commissioners will further delay the proposed purchase. There is a chance of getting the needed funding but this requires a great deal of community support.

Colington firefighters were already planning to replace one of their aging fire engines however the rating change puts greater emphasis on that replacement as the new rating system is now in place. The county has denied the needed tax increase the last two years. If the fire department rating slips due to not having the necessary apparatus, all homeowners face a potential increase in their property insurance premiums. From design to delivery, a new truck process could take as much as 9 months or even longer.

The planned ladder truck would actually be a multipurpose truck known as a Quint in the fire service. It has all of the abilities of a modern pumper plus the necessary ladder truck capacity to better meet the new standards. The department had hoped to take advantage of the almost historic low interest rates and avoid another model year price increase when requesting the funding increase.



That increase would be used to make the annual truck payments and make necessary repairs to the rest of the fleet. The CVFD's fleet of pumpers are 19, 20 and 27 years old. Obviously, technology has improved vastly over the years, as have safety standards. None of the pumpers meet the modern NFPA (National Fire Protection

Association) standard for fire apparatus. The most relied upon pumper is Engine 15. This truck is 20 years old and even lacks shoulder belts in the seatbelt system. It is in need of body repair due to rust and has other mechanical issues. Continued page 2

Manager's Report

Avoiding Conflict with the Neighbors

Can't we all can just get along? The key to good relations with your neighbors is communication. It's often the best way to prevent and resolve conflict before it reaches the legal system. You don't have to be friends or spend time together to achieve a peaceful coexistence, but you should try to be a good neighbor and follow these tips:

Say hello. At the mailbox, while walking the dog or when you see a moving van arrive, introduce yourself. Learn your neighbors' names and regularly offer a friendly greeting.

Provide a heads up. If you're planning a construction project, altering your landscaping or hosting a big party, contact your neighbors beforehand.

Do unto others. Treat neighbors as you would like to be treated. Be considerate about noise from vehicles, stereos, pets, etc.

Know your differences. Make an effort to understand each other. Differences in age, ethnic background and years in the neighborhood can lead to different expectations or misunderstandings.

Consider the view. Keep areas of your property that others can see presentable.

Appreciate them. If the neighbors do something you like, let them know. They'll be pleased you noticed, and it'll be easier to talk later if they do something you don't like.

Stay positive. Most people don't try to create problems. If a neighbor does something that irritates you, don't assume it was deliberate.

Talk honestly. Tolerance is important, but don't let a real irritation go because it seems unimportant or hard to discuss. Let your neighbors know if something they do annoys.

Be respectful. Talk directly to your neighbors if there's a problem. Gossiping with others can damage relationships and create trouble.

Remain calm. If a neighbor mentions a problem they have with you, thank them for the input. You don't have to agree or justify any behavior. Wait for any anger to subside before responding.

Listen carefully. When discussing a problem, try to understand your neighbor's position and why he or she feels that way.

Take your time. Take a break to think about what you and your neighbor have discussed. Arrange to finish the conversation at another time.



Play it Safe with Flammables


It looks as though Mother Nature has finally relinquished her hold and will be letting some of that nice weather come our way. As temperatures begin to rise and our lawns and gardens once again need attention, countless gardeners will begin hauling out their lawnmowers and rototillers. To ensure that this summer's yard chores will be free of accidents, a few timely precautions should be observed.

Equipment Safety Be cautious when fueling and using power mowers. Never refuel garden tractors, lawnmowers, rototillers, etc. while the motor is running. Always fill gas-powered equipment outside, never inside the garage, and never in the presence of a source of ignition such as open flame, a lit cigarette, etc. Remember that gasoline and petroleum product vapors are heavier than air and will seek lower levels.

General Rules Never store flammable liquids such as lawnmower fuel, Coleman fuel, charcoal lighter fluids, etc. in glass or breakable containers. If plastic containers are used, make sure they are approved for the storage of flammable liquids. Otherwise, use metal flammable liquid containers, preferably safety cans. Storing flammable liquids within the residence (including the garage) is not recommended. If, however, it is necessary, it should be limited to the garage only, and should be limited in quantities not to exceed those necessary for normal use (lawnmowers, etc.)

Open Burning The laws covering open burning are very strict. Permits are required for all open burning, even in barrels, and can be obtained by calling the Colington Fire Station at 441-6234. A site visit may be required to ensure proper safety precautions are taken. Burning must take place between 8 a.m. and 6 p.m. Currently, only limbs (less than 6 inches in diameter), yard clippings and small piles of brush may be burned. No construction debris, lumber or household trash may be burned. A small camp fire or burn barrel is allowed for social gatherings and similar purposes but may require a permit. Those types of fires may not be subject to the time restrictions. The permit issuer will let you know at the time the permit is written. All fires must be attended until completely out. Also, be a good neighbor and try to pick days when the wind helps keep smoke away from others. All open burning may be denied or permits revoked due to weather conditions. Open burning regulations may not apply when the container is designed for burning or cooking and has a chimney or smoke stack.

If An Emergency Occurs Dial 9-1-1 to report all emergencies. Be sure to give as much information as possible so the call taker can send the correct type of help. Never hang up until you are told to do so by the call taker. Is your address clearly marked? Having large, contrasting numbers on your home and at the street may make a difference in getting help promptly. Perhaps you have noticed your neighbors have a reflective address sign on their mailbox. Your fire department offers these signs for only


