

### **Maintenance Yard Fees**

Dare County is now charging the Association \$65/a ton for the commercial bins that are in the Maintenance Yard, so unfortunately we have had to change the fees charged. The discretion of maintenance yard staff will determine if fees differ due to weight and load.

- Miscellaneous Materials = \$5.00 a load
- Full sized pickup truck load = \$10.00 a load
- Materials with trailer, exceeding truck sized load = \$15.00 a load

### Reporting a suspicious activity

Reporting a crime or suspicious activity is the cornerstone of a Community Watch program. Thanks to all of you for your reporting efforts and diligence this past year. You are a key part in keeping our crime rates low in Colington Harbour.

#### REMEMBER: WHEN IN DOUBT ALWAYS CALL:

- The Sheriff's Department at 252-473-3444 will gladly take your call and proceed appropriately.
- Call 911 if your situation is an emergency.

Here are a few examples of what to report.

#### WHO WAS IT?

- Name(s) (if known) or physical description(s) (height, weight, age, color of hair/eyes, scars and tattoos)
- · Sex, ethnic background
- Clothing worn shorts, trousers, hat, shoes

#### WHAT WERE THEY DOING?

- Walking, running, bicycle, skate board, driving a vehicle, entering a house or car
- Describe the item they were using Color, make, model

#### WHEN WERE THEY DOING IT?

- · Date and time
- Have you seen them doing this before?

#### WHERE WERE THEY?

- Address or location
- What direction were they going?

#### You can still make a report even when you don't have specifics, but observe:

- Different patterns like traffic at a home or neighborhood that may only occur a few times a week, or a specific day of the week
- People in the neighborhood who don't seem to belong,
- Cars parked or occupied at unusual hours or where not usually seen.
- · Open doors or windows.

Remember that calling the **Dare County Community Crimeline** (252) 473-3111 or 800-745-2746 is a safe way (anonymous) to report suspected crimes. CrimeLine financially rewards those tips that lead to an actual arrest. Check out the web site at www.darecommunitycrimeline.org

### **Colington Fire Department**

Need For Active Volunteer Firefighters Increases

For this issue, we wanted to focus on a couple of important topics that have recently affected your fire department. Thanks for taking the time to read our articles and stay informed about what we do in the community. Visit our website at www.colingtonfd.com.

#### No Parking In Front Of or **Beside Fire Hydrants**

Occasionally we receive phone calls from the community, or firefighters come across vehicles and boats that are parked too close to fire hydrants. This presents a serious safety risk to both folks that are experiencing a fire and those of us that are fighting the fire. Blocked hydrants cause delays and



even force us to use hydrants that may be a thousand feet or more from where we need our apparatus. NC law requires 15 feet of clearance in front of a fire hydrant, and on either side. Fences may not be placed within 3 feet of a hydrant, as it greatly interferes with firefighter access to hydrants. Vegetation that obstructs hydrants must be removed as well. If you are not able to clear obstructions, or if it appears your hydrant is damaged or otherwise needs attention, please call the Dare County Water Department or us so that action can be taken to restore the hydrant to full use before it is needed and found to be unusable.

Move To The Right For Siren And Light



We can't stress enough how important it is to yield to emergency vehicles. It's the law, and it allows Fire, Police and EMS to safely and quickly respond to emergencies. Whether we approach from the rear or from the opposite direction, pull to the right shoulder as soon as you can do so safely. This is very important on the narrow roads throughout Colington. On divided lane highways, such as Croatan Highway, when we approach from the rear, pull to the right shoulder as soon as you can do so safely. Never pull into the left turn lane. That is one of the most unsafe moves you can make. If you are stopped at a red light, stay put. Don't try to move out of the way. We are trained to safely navigate around stopped cars. And remember, "Move to the right for siren and light"!

#### **Test Those Smoke Alarms**

October 5-11 was National Fire Prevention Week, and firefighters across the country visited schools, held open houses and related activities to share life safety education with everyone. CVFD was part of a team of firefighters



that visited Kitty Hawk, First Flight and Nags Head elementary schools to teach fire and life safety to students.

One major problem that affects households everywhere, including right here in Dare County, is non-working smoke alarms. Did you know that a working smoke alarm more than doubles your chances of surviving a fire in your home? Most fatal fires occur in residences late at night or very early in the morning, when nearly everyone are asleep. Smoke only deepens a person's sleep, making a simple smoke alarm a true life saving device when installed and maintained according to manufacturer's standards. Test your alarm at least once a month, and if has a 9 volt battery, replace it annually, even if it is just a backup battery for an electric smoke alarm. Clean and vacuum them often, to prevent false alarms and allow for better sensitivity to smoke. Replace smoke alarms that are older than ten years as they will lose their efficiency after that period. Call us for more information at (252) 441-6234.

#### See You Later, Summer!

It's that time of year—you're exchanged your swimsuit for sweaters and scarves just in time to roll up your sleeves and prepare you home for cooler weather. Consider adding the following items to your winterization checklist, and ensure your home is in tip-top shape for the fall and winter seasons.

- Update your window treatments. Consider switching to a denser curtain fabric for the winter months to keep your home feeling cozy and keep heating bills low.
- Schedule appliance check-ups. Your HVAC system, air ducts and hot water heater should be checked by a licensed professional to ensure all elements are in good shape for the change in weather.
- Check for leaks in the roof, possible cracks in attic windows and insufficient insulation.
- Replace weather stripping. Doors and windows need extra help to hold heat inside your home. Inspect all door and window perimeters for cracks or tears in your current weather stripping.
- Deep clean and de-clutter. Thoroughly clean your home's nooks and crannies inside and out. Ensure electrical cords, outlets and air vents are dust- and clutter-free; tidy up garages and storage areas; and clear any debris from your home's exterior, especially around vents and drains.
