The Colington Harbour Association is run by elected board members and their support staff, including the office personnel, guard gate, and maintenance. The administrative office is located inside the clubhouse at the end of Colington Road, by the marina. The clubhouse is owned by the CHA, and our hours are posted on [our website](#). We can assist with vehicle bar codes, new owner welcome packets, obtaining permits for home and lot modifications, HOA collections, boat trailer stickers, park pavilion rentals, and we are here to answer questions from residents about living in the community.

A FEW ANNOUNCEMENTS

⚓ Annual Assessments Due

It's that time of year!! Our annual mailing has been sent. Our 2020/2021 assessments will be mailed on April 1, 2020 and due on May 1, 2020. ⚓ Ordinances 8 - Rental Properties

Section 1. Notification

Owners shall inform the Association of the name of their agent or tenant, the duration of the lease and shall post a copy of these Community Ordinances in a prominent location within the rental property.

Section 2. Obligation of Owner.

Owners are responsible for notifying their tenants, whether directly or through their agent, that they must comply with these Ordinances and other applicable regulations. When notified of a violation, property owners are also responsible for taking immediate corrective action, which includes removal of the tenants from the property if necessary.

⚓ Trash Cans & Proper Disposal of Garbage

Trash Can Storage

We have been receiving many complaints from residents about trash cans being left on the curb. Our trash is picked up on Mondays and Thursdays. Our covenants require trash cans to be moved back as soon as possible after trash pickup. If you're renting your home, it is imperative that you abide by our covenants. We are having renters placing their cans out on Saturday before checking out. This allows the cans to sit out for days before being picked up by Dare County.



ORDINANCE 5 - HOUSEKEEPING

Section 5. Garbage and Trash.

(a) Garbage and trash shall be placed in containers as stated in county ordinances. Plastic bags and other debris outside containers are not allowed.

(b) Property owners are encouraged to place containers at street side on collection days only; on other days, store containers in the least visible area around or under the house

Solid Waste and Residential Pickup

We understand that no longer being able to dispose of items at the Colington Harbour Maintenance Yard poses a challenge for residents that were unable to dispose of all refuse during the Dare County bulk pick up in early March. Some residents placed these items directly into their trash cans, which jammed the truck's equipment, causing a hydraulic leak and significant spill on Roanoke Drive. This also resulted in an estimated cost of \$6000 to repair.

The truck drivers have been instructed to not pick up any trash cans that appear to be in violation of the above guidelines. Dare County will be reporting violators to the Association, which could result in possibly being fined by both Dare County and the Association.

⚓ Bulk Item Disposal

How and where do I dispose of items that are not permitted in Dare Sanitation trash cans?

There has been some confusion on which types of disposal material can be accepted at the Kill Devil Hills Recycling Center located off of Bermuda Bay Drive.

Here are links provided by the Kill Devil Hills Assistant Town Manager that will hopefully clarify what exactly is accepted at their facility and what is not.

Acceptable items DO NOT require a permit in this area. Items considered as Dry Trash unfortunately require a permit that Colington residents are unable to obtain as residents of Unincorporated Dare County (not Kill Devil Hills), and are listed here: <https://www.kdhnc.com/607/Dry-Trash-Drop-Off-Center>

With input from OBX lovers like you, and guided by your parks' needs and priorities, Outer Banks Forever will fund projects and programs that protect these natural and cultural resources, enhance your park experience, and engage the next generation in their national parks.

We will be announcing our 2020 projects this April, but wanted to give you an exclusive sneak peek at two projects coming to your nearby park, Wright Brothers National Memorial.

Through a partnership with the Outer Banks Visitor's Bureau, we are excited to launch our **Webcams in Your Parks** campaign, which will enable you to view your OBX national parks from anywhere in the world! Your support will help install webcams on the Cape Hatteras Lighthouse, the Waterside Theater at Fort Raleigh National Historic Site, and the monument at Wright Brothers National Memorial.

If you enjoy taking a stroll at Wright Brothers, we're excited to help your park install an **Aviation Trail Through Time**. This trail will extend from the renovations inside the Visitor's Center, outside into the park, with a series of 10 interpretive storytelling panels along the walkway from the First Flight Boulder to the base of Big Kill Devil Hill and the Wright Brothers monument. From the Wright Brothers' first flight, to our current pursuit of space exploration, your support can help tell the story of the progress we've made in aviation, since Orville and Wilbur took flight on the sandy dunes of Kitty Hawk in 1903.

This year promises to be an exciting one at Wright Brothers National Memorial. Here are a few special days and events to mark on your calendar:

Special Events/Fee-Free Days:

- Junior Ranger Day: April 18
- National Park Service Birthday: August 25

- National Public Lands Day: September 6
- Veterans Day: November 11
- Annual Commemoration of the First Flight: December 17

Daily Programs:

- **Wind and Sand:** 30-minute interpretive walks, where you can step back in history and discover why the Wrights chose Kitty Hawk for their flight experiments, and what life was like in the Outer Banks at the time. You will also learn about the events that led to the first powered flight on December 17, 1903, and the lasting impact their first flight continues to have on the world today.

Summer Season Programs:

- **Wright Kite:** A drop-in program where you (or your kids!) have the opportunity to fly your own kite, much like Wilbur and Orville did when they were here. This is a first-come, first-served program with 30 kites available by the park. Kids must be accompanied by an adult at all times. This program is appropriate for ages 6 years old and up.

"For people who haven't been out to Wright Brothers National Memorial before (or recently), there's a lot more here than just a monument," says Beth Hudick who oversees interpretive programs at Wright Brothers and Fort Raleigh. "You can come to see the place where the first flight was made, hear the story of that historic day, and commemorate the courage and determination of a pair of ingenious brothers who changed the way we experience the world. Locals often find winter to be one of the most enjoyable times to visit the park, without the heat and crowds of summer, and they get a better sense of what the brothers experienced in December of 1903."

⚓ No Wake Zone



Please remember that our canals and inlet are 'No Wake' zones. The inlet zone begins and ends at the outer markers. Help us to preserve the integrity of the north and south jetties by limiting your wake.

⚓ Harbour Dog Rules

Rules for 4-legged family members benefit everyone. Many dog owners love their animals as if they were a child or grandchild. But just as there are rules to keep children safe, there also are rules to keep four-legged family members out of harm's way – and that means not letting any dog run free, habitually bark, be aggressive, or get into mischief.

Even the best-trained and most well-behaved dogs are required by Dare County Ordinance 91 to be walked on a leash, not allowed to run free.

Complying with Dare County's laws isn't only good for your pet; it's also the neighborly thing to do – and it's mandated in the community's covenants, which are in place for the safety off all residents and guests.

And please remember: When walking a pet on leash, be sure and pick up your pet's waste. The community's streets are used by walkers, joggers, cyclists and others, and no resident wants to have to clean up after someone else's dog.

INLET COMMITTEE REPORT

Current Inlet Status – Boaters Take Note:

The current round of dredging is over. However, due to a recent change in datum elevation (vertical benchmark from which to measure dredging depth) imposed by CAMA, we have a controlling depth of 6 feet only at mean high water (MHW). At this time, boaters

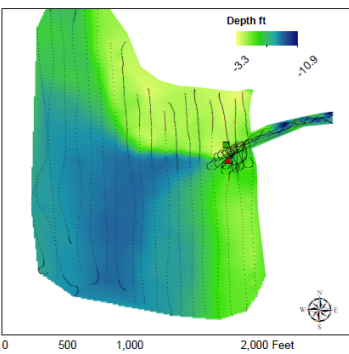
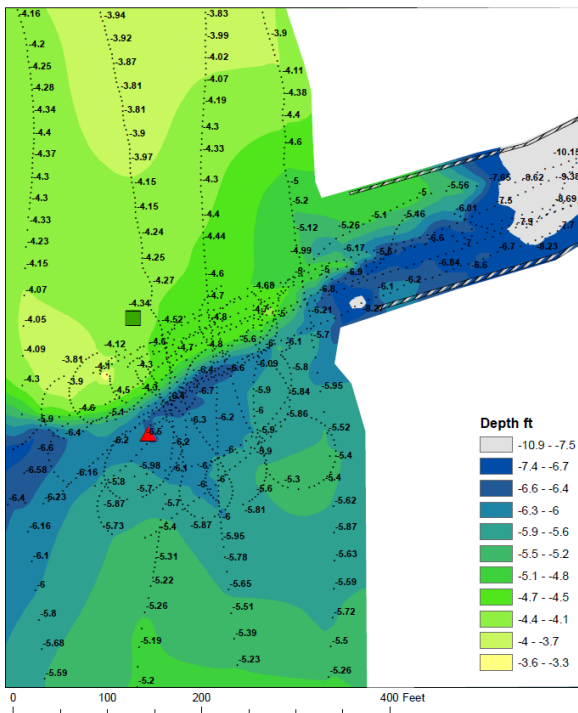


need to expect depths of 5 feet or less in some spots at mean low water (MLW). For reference, MHW level is close to the top level of discoloration on bulkheads and pilings.

The next round of dredging in the fall will be based on the historically correct vertical datum, which will allow us to increase the current depth by 1.2 feet.

To minimize shoaling inside the channel, the green day board # 1 and supporting structure are being moved slightly SSW from the current location, and the red #2-day board structure slightly SSE. To clearly mark the edges of the channel as a sharper dogleg is being introduced, additional pilings are being installed between the outer markers and the ends of the jetties.

The position of the pins approximate the location where the outer markers are being moved and the location of additional pilings being installed.



Colington Harbour Bathymetric Survey

Data collected February 22, 2020 by the U.S. Army Engineer Research & Development Center, Coastal & Hydraulics Laboratory, Field Research Facility.

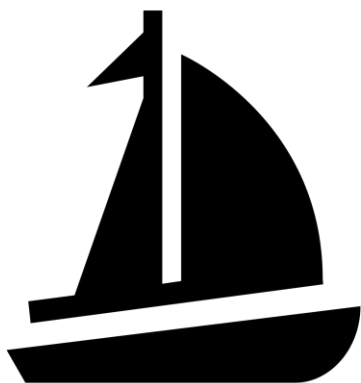

A WORD FROM THE COLINGTON FIRE DEPARTMENT

Spring Cleaning

Spring cleaning time is here! I think we all look forward to spring cleaning because it signifies a fresh start for us after the winter months. Spring cleaning can take on another meaning. It's the ideal time to check our homes and yards for dangerous materials and unsafe conditions and to spend the time to protect our families and our properties.

Start by taking a few minutes to plan your safety clean-up day. You will want to check each room in your house, including the attic and basement. Also, don't forget the garage, yard and storage shed. Plan to do several different things:

1. **Remove All Hazards.**

Check and correct things like:

- Frayed or damaged appliance cords, wiring, fuses or breakers.
- Remove piles of rubbish, trash and yard debris.
- Remove stacks of paper and magazines; take them to recycling centers.

2. **Properly Store Flammable Liquids and Home Chemicals.**

- Make sure that gasoline and cleaning fluids are well marked and are out of the reach of children and pets. Store in a cool, dry place outside the house.
- Clean up work areas. Put dangerous tools, adhesives, matches or other work items away and out of any child's reach.
- Inventory all home and yard chemicals, paints and poisons. Store them according to their label. Properly dispose of any that are expired or leaking or that look bad *but don't throw them in the trash or down the drain*
- Make sure that all chemicals are kept under lock and key and out of reach of children and pets.

3. **Check Fire Protection and Safety Equipment. *This is important!***

- Check your smoke alarm. **Do It Now** while you are thinking about it. If you need one and can't afford to buy one, call us. We'll help you. If you need help checking or replacing a battery, call us. But most importantly, make sure your smoke alarm works. Be sure to change the battery in your smoke alarm if so equipped.
- If you use any gas or wood burning appliances or heaters, install and maintain a Carbon Monoxide alarm too.
- Check fire extinguishers for proper type and placement.
- Make sure all doors and windows open easily for fast escapes.
- Can we find you in an emergency? Make sure your street numbers are posted properly and are visible. The fire department sells and installs reflective address signs that are great for quickly locating homes.

4. **Plan Your Escape Now**

- Sit down with your family and make sure that everyone knows what to do in the event of a fire.
- Make sure you have two ways out of every room and that you have a meeting place outside the house for the whole family.
- Practice the plan. Even the best plan is no good if you don't practice it!





You can do a lot to protect yourself, your family and your property. In fact, you are the key to your safety. A little time spent on simple common sense prevention will do a lot to make your house a safer place. We are here to help you! Please call us and we will show you more ways that you can protect yourself all year long.

Open Burning

Right along with spring-cleaning comes open burning. North Carolina laws are very strict in regard to open burning. In fact the only items allowed to be burned are natural vegetation, limbs, twigs and yard debris that originate on the property. **Absolutely no trash or building materials of any type may be burned, not even in burn barrels.** A permit is required for all open burning, with the exception of small camp fires or outdoor

fireplaces. The permits, available from the fire department at no charge, are issued for a maximum of 4 days and only allow burning between the hours of 8 A.M. and 6 P.M. The department may inspect the area before a permit is issued. (This does not include recreational type fires.) Try to choose days that the smoke doesn't bother a neighbor. The department may deny permits if conditions are not favorable for safe burning. Call the station for more information 441-6234 or visit our website, www.colingtonfd.com.

Colington Volunteer Fire Department Replaces Aging Apparatus

For some time, the members of the CVFD have been working hard to replace an aging fire engine that was the first custom fire truck purchased by the department. The 1994 HME / 4 Guys pumper served the community well and was the main workhorse of the department's fleet for many years.

Age and more frequent runs began to take its toll on the pumper and maintenance issues became a recurring issue for the department. That, coupled with older technology and safety essentials, led to the planning of replacing it with a modern pumper.

Having purchased a new Quint style truck in 2016, funds were very limited. A search began for a reliable used pumper as an alternative. Quality used fire apparatus are extremely hard to find and do not always satisfy the needs of a department. Fortunately, one was in Alabama that seemed to fit the department's needs of safety, reliability and modern features. After inspecting the truck, an offer was made, and the truck headed to the Outer Banks.

The 2010 Sutphen pumper offers greater safety to the firefighters, has much more compartment space and is almost a twin to the 2016 apparatus. That provides greater efficiency for driver / operators as well as crews.

A huge benefit was the reduced cost of the apparatus. After correcting a few issues mechanically and bringing the truck into compliance with modern pumper standards, the department saved well over 50 percent of the cost of a new pumper.

The department is proud to have this addition to our fleet, and happy that we were able to save a lot of money for the community as well.

Now, if a few more folks wanted to volunteer with us... But that's an article for another time!

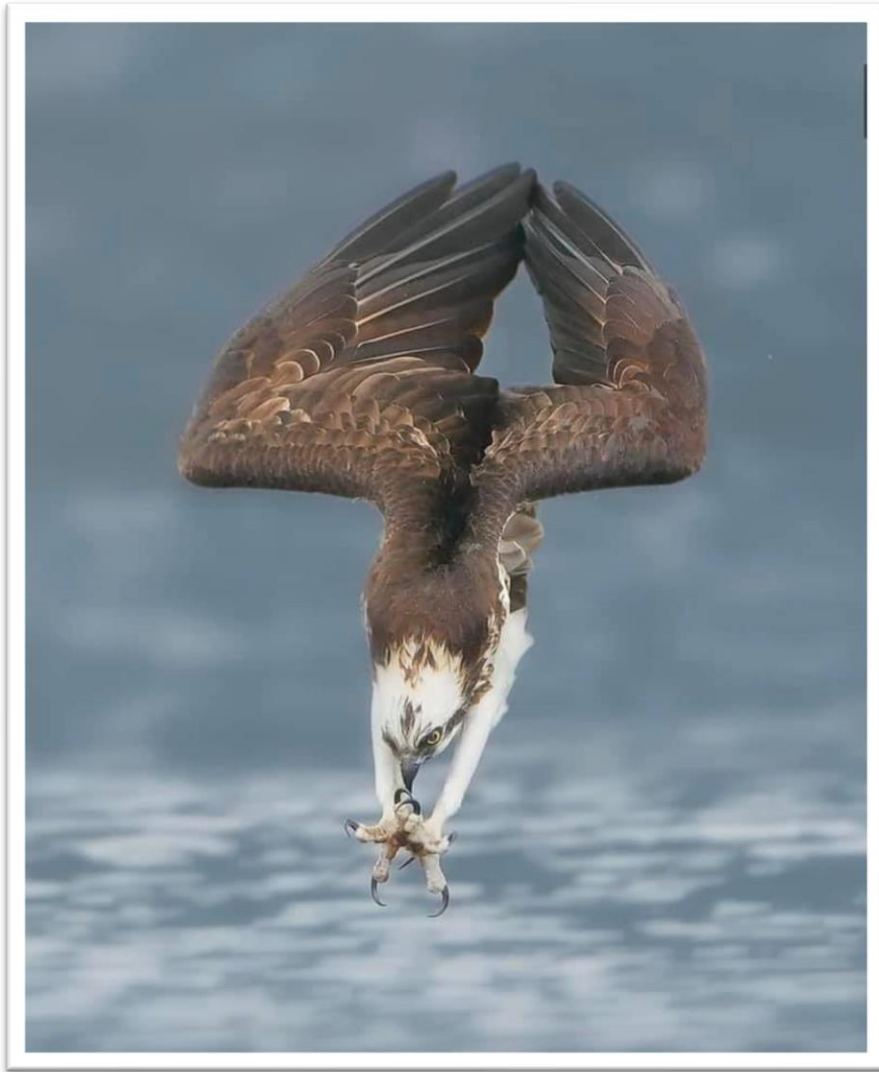
