This document, signed by 26 homeowners in good standing, is hereby submitted to the Colington Harbour Association Board of Directors on this date, 11/12/2021, for the purpose of requesting the removal of Board member, Daniel Stephen Hoggard, pursuant to the Declaration of By-Laws of Colington Harbour Association, Inc., Article V, Section 6, which states the following:

"A Director may be removed only for just cause with formal charges stated in writing and bearing the signatures of twenty-five (25) Members in good standing. Upon receiving said charges, the Board will appoint a committee of twelve (12) Members to hold hearings on the charges. No signer of the charges or no officer or member of the Board shall be a member of the impeachment committee. The chairman of this committee shall be elected by the members, and shall have full voting powers in the committee. A finding of 'just cause for impeachment' sustained by two-thirds ( $\frac{2}{3}$ ) vote of the committee shall automatically remove the impeached officer from his office."

Per the Declaration of By-Laws of Colington Harbour Association, Inc., Article V, Section 6, the following charges will provide the basis for the just cause removal of Mr. Hoggard from the Board of Directors.

Mr. Hoggard is well known in our community for his strong opinions and threatening statements. His many social media posts over the last year, which were available to the general public until approximately six months ago, were filled with violent themes and a preoccupation with weapons. As of October 19, 2021, his publicly available Facebook profile page, under his name and photo, states "I'm a great friend and an epic enemy. If you see this, we're friends. If not, watch your 6." The threatening tone continues.

Mr. Hoggard identifies himself as a "Three Percenter," an extremist group associated with resistance to the U. S. federal government. He proudly flies this flag and has the decal on his vehicle.

As of October 19, 2021, Mr. Hoggard is flying on his residence a flag depicting a profanity, "F - k Biden," with the American Flag interposed between the words and concealing two letters of the first word. His residence is the first home you see as you pass through the gate, and is located close to the school bus stop.

On October 19, 2021, in the face of outrage within the community, Mr. Hoggard posted an angry response on the Colington Neighbors page, declaring his beliefs and his rights, without acknowledging how others may have been affected by his actions. In the post, he called the president of the Board a "Marxist President" and attributed to him all manner of wrongdoing and threatened legal action.

Please find attached to this document evidence of the aforementioned conduct on the part of Mr. Hoggard. These include photographs (screenshots) from social media that accurately



reflect and document his photos and statements. These provide his name as the poster and most include the date he posted.

Also, attached is a photograph taken of the flag flown by Mr. Hoggard at his residence, taken October 19, 2021, which was described above.

Mr. Hoggard, as a Board Member, should be interested in representing our community in the most welcoming, and favorable way. The flags he flies are one of the first things a visitor to our community sees. The condition of his residence, with piles of belongings under his house, also doesn't seem consistent with efforts of the Board to maintain our community in an orderly fashion.

Any member of any Board is expected to have the ability to function within a group setting, interacting with others who are likely to have views different from her/his own. Integral in that is the expectation the Board member would be willing and able to respectfully listen to opposing views, engage in discussions, and discern what is best for the organization as a whole. Mr. Hoggard is clearly at odds with the Board President. How can he continue on the Board, given his very public name-calling and accusations? He has a pattern of refusing to accept differing opinions and instead attacks and threatens others who don't agree with him. He appears to believe that others are wrong and only he is right.

The ongoing pattern of conduct of Mr. Hoggard has created and continues to create division within our community. He clearly has no regard for societal norms. He appears to be preoccupied with violence and threats of violence, and acting in ways that provoke a reaction. This conduct calls into question his ability to exercise sound judgment when making decisions that affect others. From his public communications, it's apparent that he is unable or unwilling to set aside his very strong opinions to listen to or acknowledge the concerns or opinions of others.

Mr. Hoggard's continued involvement on the Board will only serve to undermine confidence and interfere with the efforts of the Board to work for the good of our community as a whole.

It is known that the Board has previously attempted to address Mr. Hoggard's conduct with him, in an attempt to resolve the community's concerns. Clearly, those efforts were futile as evidenced by his ongoing and current behavior.

The residents of Colington Harbour are, therefore, left with no choice but to ask, and insist, upon the removal of Mr. Hoggard from the Board.

It is expected that the process as outlined in the By-Laws for removal will commence immediately upon receipt of this document.

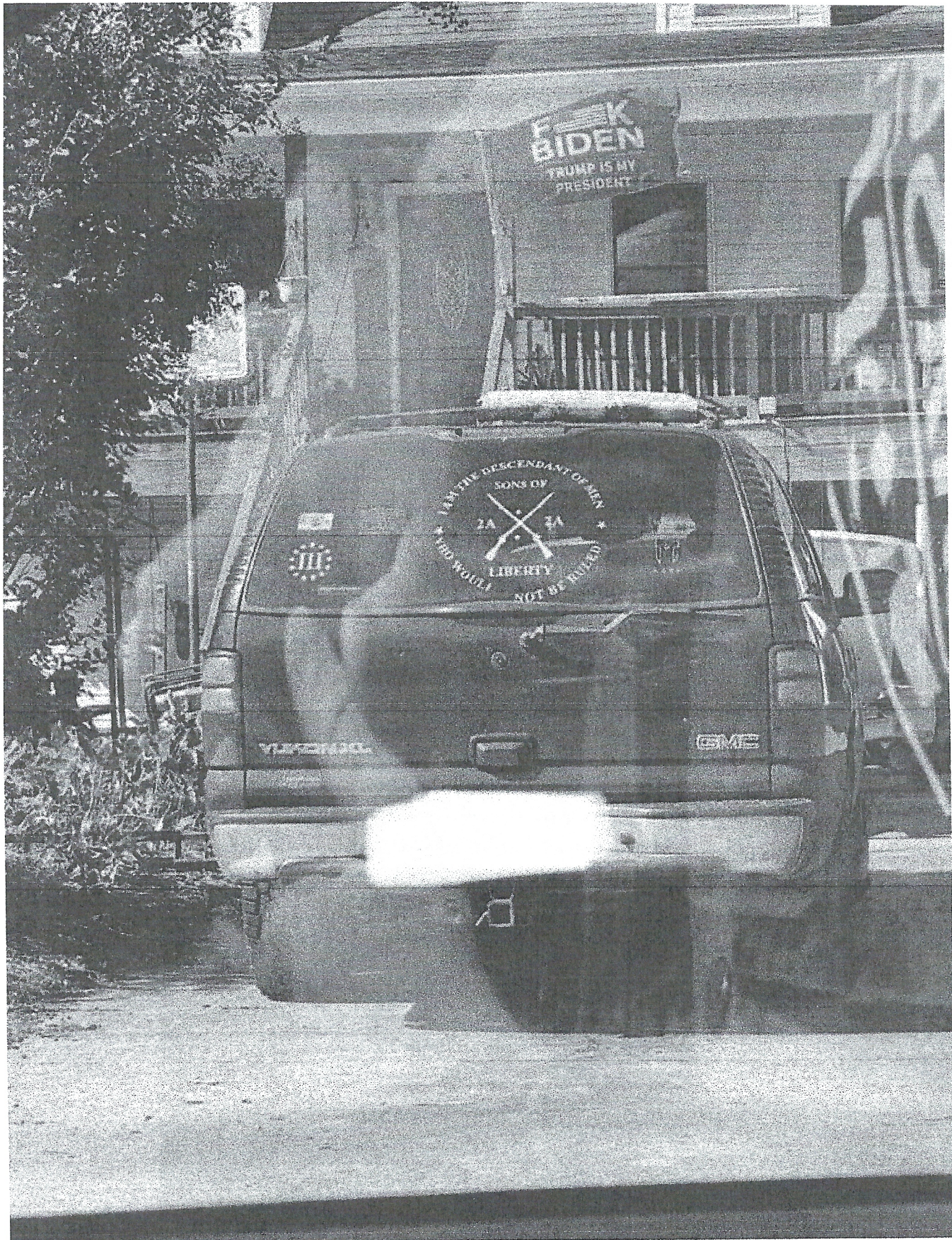
