- Officers Reports
 - 1. President Neil Schaming Reported on challenges we faced due to Covid restrictions. Second road treatment was completed in the fall. The third stage will begin in May on the southside of the gate. Road paving/repair will continue as needed. Stormwater Drainage continues to be a problem. Worst areas were identified by an engineering study. These will be completed with our maintenance team in order to save cost and complete more in a timely matter. Dredging was completed on schedule. We leased our operation to Heritage Point. The money made has helped pay for the dredge in less than three years. Limb/Branch removal will continue twice a year. Two cameras were installed at the front gate to monitor incoming and outgoing traffic.
 - 2. Treasurer John Collins John Collins reported that our Association Assessments are at a 100% collection rate, which is outstanding. Also collected \$18,000 of past due Assessments. He also explained why the assessments were increased 5%, 3% is to fund the Capital Reserve and 1.5% is for salary increases. He also anticipates there is going to be \$30,000 of unspent funds from the 2020 budget, which will be deposited into the Capital Reserve.
 - 3. Secretary Steve Ornstein Reported election results, Steve Ornstein 293, Bill Meyer 264, Leah Holmes 240, Michael Smith 223, Maggie Bryson 220, Richard Setty 183, Bobby Lawrence 151, Howard Snyder 137
